OEI Distance Mental Health for Clinicians Course Syllabus

Course Description

Distance Mental Health for Clinicians address necessary areas of consideration when working with students experiencing mental distress in the online counseling environment including assessment of student mental health needs as well as the provision of appropriate and effective referrals. Participants will take a close look at the growing trend of distance mental health, otherwise known as e-therapy services, and its importance for community college students. Included discussion and activities guide dialogue and live sessions facilitated by licensed clinicians in the field. This course is *not* intended as permission to practice as a mental health counselor or for certification or licensure.

Course Learning Outcomes

By the end of modules 1 and 2, counselors will be able to:

- Summarize the importance of CCC distance mental health services
- · Identify multiple forms of distance mental health counseling
- Explain legal and ethical guidelines of distance mental health counseling
- Identify challenges and potential solutions specific to distance mental health services
- Define and describe scope of practice at home institution

- Basic computer skills (word processing, email, file management)
- Basic internet skills (use of browser, searches, uploading/downloading files)
- Familiarity with discussion boards
- An open mind and willingness to try new things

Technical Requirements

- Fairly recent computer skills with either Mac or PC running a current operating system.
- The most updated version of Chrome or Firefox web browser to successfully access the Cranium Cafe platform.
- Fast Internet connection. Cable, broadband or DSL preferred.

Cranium Cafe Account

Prior to the beginning of the course you should have completed training using Cranium Cafe. In that training, you are expected to establish your Cranium Cafe card. If for some reason, you have not completed both of those pre-requisites, go to Cranium Cafe and click on Register in the top right corner. Then spend some time exploring the platform using materials available from the website. It is expected that counselors will begin this course with a basic understanding of Cranium Cafe. If you are using Cranium Café at your local college, please contact Jessica Hurtado so your account can be moved to the OEI instance of Cranium Café for the duration of this course. Upon completion of the course, your CC account will be moved back to your local college instance.

Textbook Information

There is no required textbook to purchase for this class. All readings will be available online in Canvas. Many of them will be in the online Canvas and Cranium Cafe guides along with articles and websites related to weekly topics. You will be able to bookmark or print them for future reference.

Strongly Recommended Tools

You will be exposed to many resources, including websites, in this class. Take time to develop a process for bookmarking these sites for future reference.

If you don't have a clear bookmarking process or tool in mind, set up a free account on a social bookmarking site like <u>Diigo</u>. Diigo is an easy way to tag and bookmark websites providing you the ability to access and share them from any computer with internet connection.
